Minor Incidents Teacher Managed

Step 1

- □ Prompt
- ☐ Redirect □ Reteach
- Choice



Behaviour stops

Behaviour continues

Give positive verbal/ social acknowledgement

Apply Behaviour Consequence (logical, individualised) Classroom

- □ Temporary removal from activity
- ☐ Alteration of activity
- Partner room referral 10 minutes
- Notification to parents
- □ Conference
- □ Reflection sheet completed

Playground

- ☐ Walk with teacher
- Loss of privilege
- Counselling with teacher

MINOR INCIDENTS

Follow PBL Minor behaviour response.

- 1. Playground teacher deals with minor incident
- 2.Playground teacher reports incident to classroom teacher

Teacher documents student's behavior in Sentral.

PLAYGROUND - Student reports or is reported to playground duty teacher **CLASS**- classroom teacher reports issue/incident to supervisor

> MINOR/MAJOR Reportable issue on playground OR in classroom

Minor **Teacher Managed**

Inappropriate verbal language

No

- Physical contact non serious but inappropriate (low level contact eg: push)
- Defiance/ disrespect/ non-compliance
- Disruption (talking while teacher is speaking; loud voices or noises indoors)
- Property misuse
- Dress code violation
- Late to class
- Partial truancy
- Cheating/ plagiarism
- Other

Major Reported to Executive

Yes

- Abusive language/ profanity
- Defiance/ disrespect/ noncompliance
- Disruption (sustained loud) talk, yelling or screaming; sustained out of seat behaviour i.e. tantrums, excessive yelling or screaming)
- Physical aggression (punch, hit, kick)
- Forgery/ theft
- Harassment/ tease/ taunt
- Property damage
- Absconding
- Cyber / bullying
- Actions considered criminal/ delinguent behaviour

MAJOR INCIDENTS

Follow PBL Major behaviour response.

- 1. Playground teacher requests supervisor follow up.
- 2. Grade Supervisor deals with issue following flow chart and completes parent phone calls and documentation
- 3. PBL coaches and classroom teacher are notified by the grade supervisor. Coaches follow up with counselling as required.

Major Reported to Executive (Exec Managed)

Playground /Class **Teacher actions**

- Inform student of rule violation
- ☐ State expected behaviour
- ☐ Student directed to go to Grade Supervisor

Grade Supervisor (Executive) actions

- □ Review incident
- Determine consequences
- Complete parent phone class and documentation
- Grade supervisor notifies classroom teacher
- ☐ Grade supervisor notifies PBL coaches



PBI coaches follow up with counselling as required.



If Behaviour continues

- Parent inter / Case Meeting
- LST Intervention
- Behaviour Management Plan
- Risk Assessment
- Complete referral for Tier 2 **Targeted Intervention**
